ABOUT EVENT: ALL families with children enrolled & registered in Woodland District 50 for the 2019-2020 school year will be required to prove residency. (New families that have not registered do not need to attend this event. Please contact the registration office at 847-596-5600 to schedule an appointment.)

Residency Documents Accepted for Proof of Residency:

RE-REGISTRATION CONFIRMATION PAGE: REQUIRED

- All currently registered families returning to Woodland from the previous year will need to complete the online returning student process in Skyward Family Access by July 15th.
- Upon completing please print the summary confirmation page and bring to proof of residency.
- Families that have not completed the online process will have to complete it at POR before proceeding through the residency event.

HOMEOWNERS - Must bring any two of the following documents:

- Current property tax bill
- July/August mortgage statement
- July/August gas, electric, water, cable or home telephone bill (NO CELL PHONE BILLS)
- Voter registration card or vehicle registration (WITH CURRENT ADDRESS LISTED)
- Homeowner's insurance policy
- Driver's license, Illinois State ID card or Matricula card.

LEASEHOLDERS/RENTERS - Please bring the following:

- Current signed and dated lease agreement or renewal with ALL occupants listed.
- Apartment complex manager letter, if requested by registration department.

AND/OR two of the following documents:

- July/August gas, electric, water, credit card bill, cable or home telephone bill (NO CELL PHONE BILLS)
- Voter registration card or vehicle registration (WITH CURRENT ADDRESS LISTED)
- Renters' insurance policy
- Driver's license, Illinois State ID card or Matricula card
- Current Public Aid card

RESIDENCY AFFIDAVIT REQUIREMENTS:

**Families MUST PROVIDE Notarized Affidavit and the district resident's homeowner documents from the list above or leaseholder's documents from the list above. Additional documents could be requested by registration department.*

**PARK CITY/ZEMAN MOBILE HOMES: Non-homeowners must provide a letter from the management office stating your family is allowed occupancy.*

Important:

-Incoming 6th graders, plan on coming to POR and have your ID picture taken. You'll be all set when you start 6th grade!

-Families will be able to submit health forms to the nurse, pay registration fees, add money to their lunch accounts, purchase spirit wear, PE uniforms for 6th, 7th and 8th grade Middle School children, and *PTA school supply packs (limited supply).
