- **Benefit letter (NOT A MEDICAL CARD)** from a welfare agency indicating:
 - TANF #
 - Food Stamp #

Without one of the above your application will be denied. After completion of the application please forward your application to one of your children’s principals. Only one fee waiver per family is required.

Upon receipt of your application, the principal will review and respond to you within 10 days.
